This evaluation report shall address all areas that Delta addressed in its most recent evaluation report and all subject areas that are identified in this Order; (6) Within 30 days of the date of this Order, Delta shall revise the notice that presently appears on all customer bills to accurately reflect the present nature and level of customer funding for the EAP; (7) Within 20 days of the date of this Order, Delta shall file revised tariff sheets that reflect the conditions approved in this Order and the present nature and level of customer funding for the EAP.
