 (1) The charges and credits applied by Taylor County through the FAC for the period from November 1, 2006 to October 31, 2008 are approved.
 (2) Taylor County is authorized to transfer to base rates those fuel costs (as adjusted for line-loss) rolled in by East Kentucky from its FAC to its current base rates.
 (3) The rates in the Appendix to this Order are approved for service rendered by Taylor County on and after August 1, 2009, the effective date of East Kentucky's change in rates.
 (4) Within 20 days of the date of this Order, Taylor County shall file with the Commission revised tariff sheets setting out the rates approved herein.

 (1) A public hearing shall be held on March 17, 2009 at 10:00 a.m., Eastern Daylight Time, at the Commission's offices in Frankfort, Kentucky. If no interested party files written notice of its intent to attend this hearing with the Commission by March 13, 2009, the public hearing shall be cancelled.
 (2) Taylor County shall file with the Commission, not later than 21 days from the date of this Order, an affidavit attesting to its compliance or noncompliance with the requirements of 807 KAR 5:056.
 (3) Taylor County shall publish a notice not less than 7 days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in a trade publication or newsletter going to all customers. Taylor County shall also file an Affidavit of Publication of Hearing Notice with the Commission when received from the publisher, but no later than March 13, 2009.
 (4) Taylor County shall, not later than 30 days from the date of this Order, file with the Commission the original and 5 copies of the information listed in Appendix A.
