(4) To the extent permitted by law and consistent with KRS 278,200. Brandenburg's proposed revised wholesale rate is suspended from November 20, 2012 up to and including April 19, 2013. (5) The procedural schedule set forth in Appendix A to this Order shall be followed. (6) Brandenburg shall file with the Commission no later than January 15, 2013 an original and five copies of the information listed in Appendix B to this Order. Brandenburg's response shall comply with the provisions of ordering paragraph 7 of this Order. (7) a.
