(2) In the second full-billing month following the date of this Order, KU shall decrease its jurisdictional environmental revenue requirement by \$218,511 for one month. (3) Beginning in the second full-billing month following the date of this Order, KU shall use an overall rate of return on capital of 7.23 percent, a tax gross-up factor of 0.64, a return on equity rate of 10.25 percent, and an overall grossed-up return of 10.30 percent in all future monthly environmental surcharge filings unless directed otherwise by the Commission.
