Pursuant to KRS 61.878(1)(m), the AMP, excluding the cover page, table of contents, and Executive Summary, is granted confidential protection and shall not be placed in the public record or made available for public inspection for an indefinite period of time, or until further Order of the Commission. 3. The AMP cover page, table of contents pages i-vii, and Executive Summary through page E-19, do not fall within the scope of KRS 61 .878 and are therefore denied confidential protection. Pursuant to 807 KAR 5:001, Section 13(5), these pages shall not be placed in the public record for the period permitted to request rehearing or bring an action for review. 4. Use of the materials granted confidential treatment in any Commission proceeding shall be in compliance with 807 KAR 5:001, Section 13(9). 5. Movant shall inform the Commission if the materials granted confidential treatment become publicly available or no longer qualify for confidential treatment. 6. If a non-party to this proceeding requests to inspect materials granted confidential treatment by this Order, the Movant shall have 20 days from receipt of written notice of the request to demonstrate that the materials still fall within the exclusions from disclosure requirements established in KRS 61.878.
