The current members of the Graves District board of commissioners shall, in accordance with KRS 74.363(2), continue to serve as members of the board of commissioners of the resulting district for one year from the date of this Order. 4. No later than one year from the date of this Order, Graves District shall file documentation of compliance with KRS 74.363(3). which requires appointments to be made to its board of commissioners with initial terms of two years for approximately one-third of the commissioners, three years for approximately one-third of the commissioners, and four years for the remaining commissioners. 5. Graves District shall establish two divisions. Division 1 shall contain the customers of Graves District's current service territory. Division 2 shall contain the customers of Sedalia District's current service territory.  6. Within 30 days of the date of this Order, the resulting district of this merger shall file an adoption
	notice in accordance with 807 KAR 5:011, Section 11, adopting, ratifying, and making its own the rates, rules, classifications, and administrative regulations of Graves District and Sedalia District in effect at the time of the merger.
