No later than September 1, 2018, Edmonson shall submit its Gross Report and an annual report for the calendar year ending December 31, 2017, and its Gross Report and an Annual Report for the period January 1, 2018, through the date of the transfer. 6. Any documents filed pursuant to ordering paragraphs 2, 3, and 5 shall reference this case number and shall be retained in Edmonson's general correspondence file. |
