Final Order Entered: 1. Muhlenberg District #3's request to deviate from the water storage requirements of 807 KAR 5:066, Section 4(4), is granted and approved through February 28, 2019. 2. Muhlenberg District #3 shall inform the Commission in writing if changes occur in either system that would cause Central City to have insufficient storage for Muhlenberg District #3, or if Central City gives notice that it is revoking the November 22, 2016 letter. 3. In the event that Muhlenberg District #3 has neither secured a written agreement with, nor been acquired by Central City; Muhlenberg District #3 shall file an application for a deviation from 807 KAR 5:066, Section 4(4), on or before February 28, 2019. This request for deviation shall include detailed plans and cost estimates for adding an additional 222,000-gallon tank to its storage facilities as well as detailed support for efforts to negotiate a written storage agreement with Central City, including but not limited to all emails, letters, and notes from any meeting that have taken place. 4. The Executive Director is delegated authority to grant reasonable extensions of time for filing of any documents required by this Order upon Muhlenberg District #3's showing of good cause for such extension. 5. Any documents filed in the future pursuant to ordering paragraph 2 shall reference this case number and shall be retained in the post-case correspondence file. 6. This case is closed and removed from the Commission's Docket.
