Final Order Entered: 1. Northern District is granted a CPCN to construct the Oliver Rd. Project as set forth in its application. 2. Northern District shall immediately notify the Commission upon knowledge of any material changes to the Oliver Rd. Project, including but not limited to increase in cost, any significant delays in the construction of the water main, or any changes in the route of the water main.

3. Any material deviation from the construction approved by this Order shall be undertaken only with the prior approval of the Commission. 4. Northern District shall file with the Commission documentation of the total costs of the project, including the cost of construction and all other capitalized costs, (e.g., engineering, legal, administrative, etc.) within 60 days of the date that construction authorized under this CPCN is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the Commission. 5. Northern District shall file a copy of the "as-built" drawings and a certified statement that the construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of the substantial completion of the construction certificated herein.
