Kentucky to seek a remedy afforded by law.

Duke Kentucky shall continue to use the base fuel cost of \$0.023837 per kWh. 3. The charges and credits applied by Duke Kentucky through the FAC for the period from November 1, 2016, through October 31, 2018, except for costs related to the Green Hat default, are approved. 4. Beginning with the expense month for February 2020, Duke Kentucky should credit an amount equal to \$37,079.84 for three months until May 2020. 5. Duke Kentucky shall file with the Commission, within 20 days of the date of entry of this Order, the original and an electronic version of the information requested in the Appendix to this Order. 6. a.
