The proposed facility consists of a tower not to exceed 310 feet in height, with attached antennas, to be located State Route 2194 W, Hickory, Graves County, Kentucky 42051. The coordinates for the proposed facility are North Latitude 36° 50' 23.71" by West Longitude 88° 40' 32.73". 2. The Joint Applicants shall immediately notify the Commission in writing if, after the antenna tower is built and utility service is commenced, the tower is not used for three months in the manner authorized by this Order. 3. Documents filed, if any, in the future pursuant to ordering paragraph 2 herein shall reference this case number and shall be retained in the post-case correspondence file. 4. This case is closed and removed from the Commission's docket.

AT&T Mobility shall publish notice of the time and place of the local public hearing in a newspaper of general circulation in Graves County. 6. AT&T Mobility shall provide written notice of the time and place of the local public hearing to the residents of Graves County that requested the local public hearing, and to the Graves County Judge Executive.
