Within 20 days of date of service of this Order, Cumberland District shall file with this Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates and charges approved by this Order and their effective date, and also stating that the rates and charges were authorized by this Order. 6. Cumberland District shall use the midpoint of depreciable lives of NARUC Study ranges, as recommended by Commission Staff, to depreciate water plant assets for accounting purposes in all future reporting periods. Cumberland District shall not make adjustments to accumulated depreciation or retained earnings to account for this change in the accounting estimate. 7. Within six months of the date of this Order, Cumberland District shall file evidence that its commissioners' salaries were fixed by the Cumberland County Judge/Executive and approved by Cumberland Fiscal Court.
