NOTICE OF CHANGE ORDER NO. ONE
Re: Contract Quantity, Contract Price

Effective April 1, 2026, Buyer and Seller hereby agree to amend the above-referenced Confirmation as follows to increase the Contract Quantity by 100,000 Tons:

The Contract Quantity section of the Confirmation is deleted in its entirety and replaced with the following:

Contract Quantity: The total Contract Quantity for the Term is 700,000 Tons, of which approximately 400,000 Tons will be delivered in 2027, and the remaining balance of approximately 300,000 Tons to be delivered in 2028. The option to increase each quarter's volume by 10% stated in the Contract Flexibility section below would be additional volume over and above the Contract Quantity.

Contract Quantity to be delivered FOB barge on a mutually agreeable shipment schedule during the Term (each barge shall constitute a Shipment).

The Contract Price section of the Confirmation is deleted in its entirety and replaced with the following:

Contract Price: Except as provided for under Schedule 7, Quality Adjustments, of the Master Agreement Number KPCO-BCS-2021 (the "Agreement"),

\$87.40 per Ton for the first 400,000 Tons
\$89.15 per Ton for the remaining Tons

The above stated Contract Price per Ton is FOB barge at the Designated Delivery Point.
