- 1. Capitalized Terms. This Schedule incorporates the terms and conditions of that certain Master Net Railcar Lease dated as of __oetober 29, 2025 ____ (as modified from time to time, the "Agreement") between CIT Equipment Financing, LLC ("CITEF"), First-Citizens Bank & Trust Company ("FCB"), and Lessee, provided that (i) for the purposes of this Schedule, any reference in the Agreement to "Lessor" therein shall mean FCB as "Lessor" under this Schedule, (ii) the term "Lease" when used in the Agreement shall mean a Schedule, and solely to the extent incorporated therein by reference, the Agreement and (iii) notwithstanding any language to the contrary contained in the Agreement, (a) this Schedule shall constitute an agreement separate and distinct from the Agreement and all other Schedules thereunder, (b) CITEF is not the Lessor under this Schedule and shall not have any rights or obligations under the Agreement as it relates to this Schedule, and (c) in the event of a conflict between the provisions of the Agreement and this Schedule, the provisions of this Schedule shall control. All capitalized terms defined in the Agreement shall have the meanings defined therein when used in this Schedule No. 01 except that the term "Cars" as used herein shall only refer to the equipment described in this Schedule unless otherwise indicated.
- Cars Leased. Lessor hereby leases the following Cars to Lessee subject to the terms and conditions of the Agreement and this Schedule.

- Acceptance. The Cars are currently in the possession, use and service of Lessee and therefore, are deemed accepted without any further actions by either party under the Agreement and this Schedule.
- 4. Lease Commencement Date. January 1, 2026.
- 5. Expiration Date. December 31, 2030.
- 6. Commodities to be carried. Lessee will use the Cars for carrying only:

- 7. Party Responsible for Maintenance. Lessee.
- 8. Remarking Responsibility. Lessee shall bear the costs associated with remarking each Car's road mark and number to a Lessee designated mark and number at Lease Commencement and to a Lessor designated road mark and number at lease expiration or earlier termination. Such remarking shall be performed at a facility mutually agreed to by Lessor and Lessee. Remarking shall include (i) reprogramming of the automatic equipment identification tags to conform with new reporting marks, and (ii) any transportation involved in moving each Car to and from a suitable work area to perform the remarking.

- 9. Delivery Location. Cars are already in the use, possession, and service of Lessee.
- Rent. Lessee shall pay Lessor a fixed rent payment of \$152.00 per Car per month, payable in advance.
 Rent payable for any period which is less than a full month shall be prorated. Rent shall commence under this Schedule on January 1, 2026 ("Rent Commencement Date").
- 11. Settlement Value. The amount payable to the owner of the Car under Interchange Rule 107.
- 12. <u>Return Provisions.</u> In addition to the return obligations in Section 12 of the Agreement, Lessee shall provide Lessor at least thirty (30) days written notice prior to the return of any Car. Disposal and labor charges will be assessed for commodity removal and disposal. Upon expiration or earlier termination of this Schedule, Lessee shall return the Cars to a location on the CSX, NS, or PAL line not more than 500 miles of Lessee's E.W. Brown generating station in Mercer County, Kentucky.

 - a) <u>Loading Authority</u>. Whenever approval of the originating line haul carrier is required in order that Cars may be placed in service pursuant to then current AAR Rules, (including without limitation OT-57), Lessee shall obtain such approval, and this Schedule shall continue in full force and effect notwithstanding any withdrawal or modifications of such approval or failure to obtain such approval.
 - b) <u>Transportation Expenses</u>. Transportation expenses associated with returning the Cars at lease expiration or earlier termination shall be for Lessee's account.
 - c) <u>Unit Train Service</u>. Notwithstanding Section 9A (iii) of the Agreement, the Cars under this Schedule may be utilized in unit train service.
- 15. Counterparts; Chattel Paper. This Schedule may be executed in any number of counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument. The parties agree that all facsimile or other electronic copies of this Schedule and signatures hereto shall be deemed to be originals. To the extent that this document constitutes tangible chattel paper under the Uniform Commercial Code, no security interest in this document may be perfected through transfer and possession of any counterpart other than the counterpart stamped by the Lessor as the "Original Chattel Paper."
