## RE: LG&E/KU Coal Supply Agreement No. J16007/Amendment No. 4 – Truck Delivery Point

#### Dear Creston:

This letter memorializes the agreement of the parties to amend, as applicable, the Delivery and Base Price and other parameters noted below of the above-referenced Coal Supply Agreement (the "Agreement"). The amendment contemplated by this letter shall be effective only during the period of June 1, 2018 to June 30, 2018 (the "Period"), unless extended or renewed by mutual consent of the parties. Unless otherwise defined herein, defined terms shall have the meanings assigned to them in the Agreement.

The parties hereby agree that, upon the request of Buyer and agreement by Seller, coal may be loaded and delivered pursuant to the Agreement using an alternate Truck Delivery Point of E.W. Brown Station coal stockpile located at 815 Dix Dam Road, Harrodsburg, Kentucky 40330. In such instances, the alternate associated FOB Delivered price will apply to all such coal transported via truck to the E.W. Brown Station coal stockpile.

#### **Truck Delivery Point**

Upon request of Buyer, Seller will make best efforts to load and deliver coal hereunder to Buyer FOB E.W. Brown Station coal stockpile located at 815 Dix Dam Road, Harrodsburg, Kentucky 40330 (the "Truck Delivery Point"). Unloading hours will be from 07:00 to 17:00 hours, Monday through Saturday. Trucks are expected to refrain from traveling through the town of Burgin, KY.

Title to and risk of loss of coal sold will pass to Buyer, and the coal will be considered to be delivered when coal is dumped at the Truck Delivery Point.

Seller shall arrange and pay for all costs of: (i) transporting the coal from the Coal Properties or other authorized source mines as provided herein to the Truck Delivery Point.

#### FOB E.W. Brown Station Delivered Price

A Truck Component shall be added to the adjusted FOB Railcar Base Price for any coal delivered by truck. The June 2018 Truck Component will be \$23.80 per ton.

The June 2018 FOB E.W. Brown Station Delivered Price will be \$65.47 per ton.

#### Shipment

Each day's deliveries by truck that are received and unloaded at Truck Delivery Point is herein called a "Shipment". Shipments are from Seller's stockpile(s) located at the Wild Boar Mine located in Lynnville, Indiana or the Somerville Mine located in Somerville, Indiana ("Shipping Point(s)"), all trucks are expected to conform to the Indiana and Kentucky Department of Transportation rules and regulations, and Seller is responsible for all costs incurred. Failure to adhere to either Indiana or Kentucky DOT rules and regulations may result in termination of truck deliveries under this letter agreement relating to CSA No. J16007 at the sole discretion of Buyer, without limitation as to any other rights or remedies.

### Weights, Sampling and Analysis

For Truck Deliveries: Section 7. <u>Weights, Sampling and Analysis</u> shall be amended to provide for Seller's certified truck scales at each shipping point to be applied to coal delivered to the Truck Delivery Point hereunder.

#### **Quality Price Adjustments**

For Truck Deliveries: Section 8.2 (a) <u>BTU True Up</u> will exclude the Truck Component of (\$23.80 per ton) from the calculation; the BTU adjustment for the month of June 2018 will use a Base Price of \$41.67 for all coal delivered by truck.

In all other respects, the terms, pricing and other conditions of the Agreement shall remain the same. To the extent applicable, this letter agreement shall act as an amendment to the Agreement with respect to the matters herein.

Please indicate your agreement to these terms by signing where indicated on both of the originals and returning both originals to me. I will have them signed on behalf of LG&E/KU and return a fully executed original to you.
