For the limited purpose of this report, a "Major Project" is defined as one which is not in the ordinary course of business, and will increase your current utilityplant by at least 20 percent.

Brief Project Description: (improvement, replacement,building construction, expansion. If expansion, provide the estimated number of new customers):

1) ARPA Water Main Project - These are to unserved roads: Chester Lane: 2,900 LF 4-inch, Sirocco Rd: 21,000 LF 6-inch, Milan Rd: 6,200 LF 4-inch, Lone Star Rd: 1,500 LF 4-inch, Big Dipper Rd: 1,300 LF 4-inch, Poplar Ct: 1,500 LF 4-inch.

2)  
HWY 1638 Interconnect – MCWD has only one feed of wholesale water which is located near the Hardin Co. line along Hwy 313. This project is to establish a new second interconnect near the corner of Hwy 31W and Hwy 1638, which will increase the quantity of water available to meet demand. New pump station, New ground storage tank (750,000 gal – 1,000,000 gal), 50,000 ft – 12" or 16" Transmission Main.

3)  
Pump Station, Transmission Main Line and Payneville Water Tank Upgrades - Both pump stations have reached capacity and require larger pumps/motors. The transmission main is undersized (currently 8-inch and 10-inch) and needs to be upsized to 16-inch to meet demand needs. The Payneville elevated water tank was inspected in 2022 and is due for completed sand blast and painting. Also, as there is no internal piping, a drain line is required to maintain water quality. The site requires stormwater drainage piping to move water away from the site and neighboring farm. Flaherty Pump Station Rehab, Transmission Main upgrade to 16" from Flaherty tank to Garrett Tank, Payneville Tank rehab, Paint, New piping, 2 New control valves, Drainage piping.

Projected Costs and Funding Sources/Amounts:

1) MCWD will install as much as possible with the available grant dollars. Expecting \$1,444,337 grant.

2) Estimated Total cost: \$13,000,000 - \$8,035,000 Grant, balance will be through a USDA Rural Development Loan.

Estimated total cost for projects is \$3,500,000. Expected to source borrowing from USDA Rural Development.
