Major Water Projects

For the limited purpose of this report, a "Major Project" is defined as one which is not in the ordinary course of business, and will increase your current utilityplant by at least 20 percent.

Brief Project Description: (improvement, replacement,building construction, expansion. If expansion, provide the estimated number of new customers):

1. The first project that is likely to begin construction will be a connection to Warren County Water at a point on Hwy 101 and Hwy 31W. This connection will allow the District to be able to receive by contract 1,000,000 per day if needed.
2. The second project that is in the design phase and estimated to begin construction as early as 2027 will be the redesign and updating of the Brownsville treatment plants raw water intake. Work involved in this work will restructure where the plant currently draws water from Green River, adding new pumping abilities, air burst systems to manage silt and settlement, grit removal, electrical upgrades and enhanced back up generation.
3. The third major project will be updating the existing water treatment plant. Its last update came in 2002. Updates will include updated electrical, enhanced safety, back up generation, solids management, addition of Ultraviolet Disinfection, updated chemical feed units, conversion from gas chlorine to sodium hypochlorite. Updated and modernized lab, and updated SCADA allowing better control of the process systems of treatment.

Projected Costs and Funding Sources/Amounts:

1. This is an estimated \$6,000,000 project building approximately 23,000 ft. of 12"main line and the construction of a booster pump station. This project will be mostly if not all funded through monies from House Bill 1 grants received during the 2024 Kentucky legislative session.
2. This project will be completely funded from a federal earmark of \$14,000,000 received as a result of the 2026 federal budget.
3. This project will be mostly funded from a \$9,500,000 federal earmark received as a result of the 2026 federal budget.
