12/27/05 Letter requesting an extension of the information in Appendix B of Commission's Order from the City of Manchester

11/01/05 Order entered: Manchester's proposed rate revision suspended for 5 months from 11/01/2005 up to and including 3/31/2006; North Manchester is granted full intervention; Procedural schedule in Appendix A to Order; Manchester shall, no later than 1/06/2006, file with the Commission the original and 6 copies of the information listed in Appendix B, with a copy to all parties of record. Each copy of the requested information shall be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
