2009 & each year thereafter, NKWD will adjust surcharge to reflect number customers as of 12/31 of preceding year. Surcharge shall not exceed \$30; (5) In 2008 & each calendar year thereafter, NKWD shall submit written report stating: a. number customers as of 12/31; b. total surcharge billed during preceding calendar year; c. total surcharge billed since date of this Order; (6) In 2012, NKWD shall describe how Subdistrict F has been integrated into NKWD's overall operations; (7) NKWD shall maintain separate accounts for billing & collecting surcharge; (8) Within 20 days of the date of this Order, NKWD shall revise its rate schedules to contain the Subdistrict F surcharge & description of area; (9) NKWD shall maintain current description of Subdistrict F in its rate schedules as long as surcharge is effective; (10) All persons who receive service through Subdistrict F or water mains lateral to or extensions of facility & are not part of any NKWD subdistrict shall be considered Subdistrict F & be assessed surcharge.
