 (1) The charges and credits applied by Kentucky Power through the FAC for the period November 1, 2006 to October 31, 2008 are approved.  
 (2) Kentucky Power's proposed base fuel cost of 28.40 mills per kWh is approved.  
 (3) The rates in the Appendix are approved effective with Kentucky Power's first billing cycle for July 2009.  
 (4) Beginning with its first billing cycle for July 2009, Kentucky Power shall use an FAC rate based on a base fuel cost of 28.40 mills per kWh.  
 (5) Within 20 days of the date of this Order, Kentucky Power shall file with the Commission its revised tariff sheets setting out the rates approved herein.
