- (2) The amounts billed by KU through its environmental surcharge for the period from May 1, 2009 through October 31, 2009 are approved.
- (3) KU shall add \$617,651 to its jurisdictional environmental revenue requirement determined in each of the first four billing months and \$617,650 in the next two months beginning in the second full month following the date of this Order.
- (4) KU shall use an overall rate of return on capital of 7.84 percent and a tax gross-up factor of 0.580 in all monthly environmental surcharge beginning in the second full month following the date of this Order.

- (5) c. Any party shall make timely amendment to any prior response.
- (5) d. Any request a party fails to furnish the requested information, that party shall provide a written explanation.
- (5) e. Careful attention should be given to copied material to ensure that it is legible.
- (6) Within seven days of the Commission granting intervention to a party, KU shall provide the party with a copy of its monthly environmental surcharge reports.
- (7) KU's monthly environmental surcharge reports and supporting data for the review periods shall be incorporated by reference into the record of this case.
- (8) The case records of Case Nos. 1993-00465, 2000-00439, 2002-00146, 2003-00068, 2003-00434, 2004-00426, and 2006-00206 shall be incorporated by reference into the record of this case.
- (9) Motions for extensions of time with respect to the schedule shall be made in writing.
