  - (1) Big Rivers Electric Corp. ("Big Rivers") shall appear at the Commission's offices at 211 Sower Blvd, Frankfort, Kentucky on March 23, 2010 at 10:00 a.m. to submit itself to examination on the application of its Fuel Adjustment Clause from May 1, 2009 through October 31, 2009.
  - (2) Big Rivers shall file with the Commission no later than March 23, 2010 proof of publication of its notice for the hearing.
  - (3) a. The information requested in the Appendix to this Order is due within 21 days of the date of this Order.
  - (3) b. Each response shall be answered under oath.
  - (3) c. A party shall make timely amendment to any prior response if it obtains information which was incorrect when made.
  - (3) d. Any request a party refuses to furnish the requested information, that party shall provide a written explanation.
  - (4) Any party who wishes to file testimony in this proceeding or to request information from Big Rivers may petition the Commission for a procedural schedule.
  - (5) All documents that Big Rivers filed with the Commission pursuant to 807 KAR 5:056, Section 1(7) and (9), during the period under review are incorporated by reference into the record of this proceeding.
  - (6) The official record of the proceeding shall be by video only, unless otherwise requested by a party to this proceeding.
