(1) The social security numbers and employer tax identification numbers contained in TCEA's application shall be afforded confidential treatment.  
(2) The Executive Director shall remove TCEA's application from the Commission's public files and shall substitute a copy in which all social security numbers and employer tax identification numbers have been redacted.

02/16/10 Order Entered:  
(1) TCEA is granted a Certificate to provide wastewater treatment and collection services within the troublesome Creek Watershed.  
(2) TCEA is granted a Certificate to proceed with the proposed construction as set forth in its application.  
(3) TCEA shall notify the Commission prior to performing any additional construction not expressly authorized by this Order.  
(4) Any deviation from the construction approved shall be undertaken only with the prior approval of the Commission.  
(5) TCEA shall file a copy of the "as-built" drawings and a certified statement that the construction has been completed in accordance with the contract plans within 60 days of completion of the construction.  
(6) TCEA shall require construction to be inspected under the general supervision of a licensed professional engineer with a Kentucky registration in civil, electrical, or mechanical engineering.  
(7) TCEA shall not begin providing wastewater treatment and collection service to the public for compensation until it has file with the Commission schedules showing all rates and conditions.  
(8) Subject to the filing of timely petition for rehearing pursuant to KRA 278.400, these proceedings are closed.  
(9) Any documents filed pursuant to Ordering Paragraph 5 shall reference this case number and shall be retained in the utility's general correspondence file.
