 (1) NKWD is granted a Certificate to proceed with the proposed construction as set forth in its application.  
 (2) KNWD is authorized to enter into a loan with KIA for \$8,000,000 with an interest rate not to exceed two percent per annum and a repayment period not to exceed 20 years. (3) NKWD shall notify the commission prior to performing any additional construction not expressly authorized by this Order. (4) Any deviation from the construction approved shall be undertaken only with the prior approval of the Commission. (5) NKWD shall file a copy of the "as-built" drawings and a certified statement by a professional engineer that the construction ahs been satisfactorily completed in accordance with the contract plans and specifications within 60 days of the substantial completion of the construction certificated herein. (6) NKWD shall require construction to be inspected under the general supervision of a licensed professional engineer. (7) NKWD shall advise Commission of final terms of loan agreement within 30 days of the execution date. (8) NKWD shall use proceeds from its proposed loan agreement with KIA only for the purposes set forth in its application. (9) Any documents filed in the future to Ordering Paragraphs 5, 6, and 7 shall reference this case number and shall be retained in the utility's general correspondence file.
