- (1) Kentucky Frontier's proposed acquisition of control of Cow Creek and Dema is approved.
- (2) Commission authorization of the proposed acquisition of control is effective for one year from the date of this Order and shall lapse if not completed within this time period.
- (3) Within 20 days of completion of the transfer of control as approved, Kentucky Frontier shall notify the Commission in writing of the completion thereof.
- (4) Within 20 days of the completion of the approved acquisition, Kentucky Frontier shall file a signed and dated adoption notice in accordance with 807 KAR 5:011, Section 11.
- (5) Within 10 days of the filing of such adoption notice, Kentucky Frontier shall issue and file with the Commission in its own name the utility's tariff.
- (6) Within 20 days of the completion of the proposed transfer, Kentucky Frontier shall file the journal entries it proposes to record the approved acquisition.
- (7) The acquisition stock premium adjustment is approved for accounting purposes only.
- (8) Kentucky Frontier is authorized to use the remaining \$550,000 of the commercial bank loan from Community Trust Bank to finance the acquisition.
- (9) Change in rates proposed by Kentucky Frontier for Interstate Gas farm tap customers shall be pursuant to the statutes and regulations governing farm tap service.
- (10) Within 20 days, Kentucky Frontier shall file a tariff sheet setting forth the rates and conditions of service that will apply to farm tap customers.
