 (5) Cumberland Valley shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5).
 (6) At any public hearing, neither opening statements nor summarization of direct testimony shall be permitted.
 (7) Any objections shall be filed upon four business days' notice.
 (8) Motions for extension of time with respect to the schedule shall be made in writing.
 (9) Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
