1. Shelby Energy proposed rates are suspended for six months, up to and including January 7, 2011, matching the suspension of EKPC's proposed wholesale rate increase to Owen.

2. The procedural schedule set forth in the Appendix attached hereto and incorporated herein shall be followed.

3. a. All requests for information and responses thereto shall be appropriately bound, tabbed, and indexed and the original and seven copies shall be filed with the Commission, with copies to all parties of record. b. c. Any party shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.
