- (1) KU's request to submit this case for a decision on the existing evidence of record without a hearing is granted.
- (2) The amounts billed by KU through its environmental surcharge for the period from November 1, 2009 through April 30, 2010 are approved.
- (3) KU shall add \$577,091 to its jurisdictional environmental revenue requirement determined for one month beginning in the second full month following the date of this Order.
- (4) KU shall use an overall rate of return on capital of 7.74 percent and a tax gross-up factor of 0.550 in all monthly environmental surcharge beginning in the second full month following the date of this Order.

Order Entered:

- (1) The procedural schedule in Appendix A shall be followed in this proceeding.
- (2) KU shall appear at the Commission's offices on the date in Appendix A to submit itself to examination on the application of its environmental surcharge.
- (3) KU shall file its prepared direct testimony in support of the reasonableness of the application of its environmental surcharge mechanism.
- (4) Any party filing testimony shall file an original and ten copies.
- (5) a. The information requested here is due by the date set forth in Appendix A.
- (5) b. Each response shall be answered under oath.
- (5) c. Any party shall make timely amendment to any prior response.
- (5) d. Any request a party fails to furnish the requested information, that party shall provide a written explanation.
- (5) e. Careful attention should be given to copied material to ensure that it is legible.
- (6) Within seven days of the Commission's granting intervention to a party, KU shall provide the party with a copy of its monthly environmental surcharge reports.
- (7) KU's monthly environmental surcharge reports shall be incorporated by reference into the record of this case.
- (8) The case records of Case Nos. 1993-00465, 2000-00439, 2002-00146, 2003-00068, 2003-00434, 2004-00426, 2006-00206 and 2009-00197 shall be incorporated by reference into the record of this case.
- (9) Motions for extensions of time shall be made in writing.
