 (1) A public hearing shall be held on October 12, 2010 at 10:00 a.m. at the Commission's offices.

(4) Kenergy shall publish notice no less than seven days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in trade publication or newsletter going to all customers. Kenergy shall file an Affidavit of Publication of Hearing Notice with the Commission no later than October 8, 2010.
