	accepted. Green River Valley is authorized to issue \$3,200,000 of Waterworks Revenue Bonds that
	mature over a 40-year period at an interest rate not to exceed 2.5 percent . 5. The proceeds from the
	bond issuance shall be used only for the purposes specified in Green River Valley's application. Green
	River Valley filed an application for adjustment of rates which was
	docketed as Case No. 2009-00455. The rates approved by this Order are the same as those proposed
	by Green River Valley in that case. The Commission will address the unresolved issues presented in
	Case No. 2009-00455 by separate Order. 6. Notwithstanding ordering paragraph 5, if surplus funds
	remain after the approved construction has been completed, Green River Valley may use such surplus
	to construct additional plant facilities if RD approves of the use and the additional construction will not
