Ordering Paragraph 9 of the Commission's June 3, 201 1 order shall be amended as follows: Following the filing of the quarterly safety audit documents for the second quarter of 2012, Meade County shall file with the Commission copies of the safety audit documents performed by its own safety staff on a quarterly basis through the second quarter of 2013. Quarterly safety audit documents shall be filed on or before the day of the second month following the final month of the quarter for which the documents are being filed. 4. The remaining sections of the Commission's June 3, 201 I Order shall remain unchanged. 5. The August 9, 2011 hearing is cancelled.
