02/25/11 Order Entered: 1. Crittenden-Livingston District's motion to deviate from 807 KAR 5:001, Section 11 (2)(a), is granted. Crittenden-Livingston District's application is considered filed as of January 4, 2011. 3. Crittenden-Livingston District is authorized to enter into Sublease Agreement with the County of Livingston, Kentucky to borrow no more than \$2,500,000 for the purpose of permanently refunding and retiring its Kentucky Rural Water Finance Corporation Series 2009A Note. 4. Within 30 days of executing the proposed agreement, Crittenden-Livingston District shall advise the Commission in writing of the date on which the agreement was entered, the actual interest rates, and the principal amount. 5. The proceeds from the transaction authorized herein shall be used only for the lawful purposes specified in Crittenden-Livingston District's application. 6. Any documents filed pursuant to ordering paragraph 4 of this Order shall reference the number of this case and shall be retained in the utility's general correspondence file. Nothing contained herein shall be construed as a finding of value for any purpose or as a warranty on the part of the Commonwealth of Kentucky or any agency thereof as to the securities authorized herein.
