05/31/11 Order Entered: The charges and credits applied by Big Sandy through the FAC for the period from November 1, 2008 through October 31, 2010 are approved. 2. Big Sandy shall deduct 6.74 mills per kWh from its base energy rates (as adjusted for line loss) to reflect the transfer (roll-in) of a negative 6.39 mills per kWh of fuel costs by East Kentucky to its base energy rates as approved in 2010- 00491. 3. The rates in the Appendix to this Order are approved for service rendered by Big Sandy on and after June 1,2011, the effective date of East Kentucky's change in rates. 4. Within 20 days of the date of this Order, Big Sandy shall file revised tariff sheets with the Commission setting out the rates approved herein and reflecting that they were approved by this Order.

A public hearing shall be held on March 22, 2011 at 10:00 a.m., Eastern Daylight Time, at the Commission's offices in Frankfort, Kentucky, to examine the application of the Fuel Adjustment Clause of Big Sandy Rural Electric Cooperative Corporation ("Big Sandy") from November 1, 2008 through October 31, 2010. If no interested party files written notice of its intent to attend this hearing with the Commission by March 18, 201 1, the public hearing shall be cancelled and the matter shall be considered submitted for decision based on the evidence in the record. 2. Big Sandy shall file an affidavit with the Commission no later than 21 days from the date of this Order attesting to its compliance or noncompliance with the requirements of 807 KAR 5056. 3. All documents that Big Sandy filed with the Commission pursuant to 807 KAR 5:056, Section 1 (7) and (9), during the period under review are incorporated by reference into the record of this proceeding. 4. Big Sandy shall publish the following notice not less than 7 days or more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in a trade publication or newsletter going to all customers. Big Sandy shall also file an Affidavit of Publication of Hearing Notice with the Commission no later than March 18, 2011. 5. The official record of the proceeding shall be by video only. 6. Big Sandy shall file with the Commission, no later than 30 days from the date of this O
