A public hearing shall be held on March 22, 2011 at 10:00 a.m., Eastern Daylight Time, at the Commission's offices in Frankfort, Kentucky, to examine the application of the Fuel Adjustment Clause of Cumberland Valley Electric, Inc. ("Cumberland Valley") from November 1, 2008 through October 31, 2010. If no interested party files written notice of its intent to attend this hearing with the Commission by March 18, 2011, the public hearing shall be cancelled and the matter shall be considered submitted for decision based on the evidence in the record. 2. Cumberland Valley shall file an affidavit with the Commission no later than 21 days from the date of this Order attesting to its compliance or noncompliance with the requirements of 807 KAR 5:056. 3. All documents that Cumberland Valley filed with the Commission pursuant to 807 KAR 5:056, Section 1 (7) and (9), during the period under review are incorporated by reference into the record of this proceeding. 4. Cumberland Valley shall publish the following notice not less than 7 days or more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in a trade publication or newsletter going to all customers. Cumberland Valley shall also file an Affidavit of Publication of Hearing Notice with the Commission no later than March 18, 2011. A public hearing will be held on Tuesday, March 22, 2011, at 10:00 a.m., Eastern Daylight Time, at the offices of the Kentucky Publ
