 - (3) All documents filed with the Commission pursuant to 807 KAR 5:056, Section 1 (7) and (9) during the period under review are incorporated by reference into the record of this proceeding.
 - (4) Jackson Energy shall publish notice not less than 7 days or more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas. Jackson Energy shall also file an Affidavit of Publication of Hearing Notice with the Commission no later than March 18, 2011.
 - (5) The official record of the proceeding shall be by video only.
 - (6) Jackson Energy shall file with the Commission no later than 30 days from the date of this Order, the original and 10 copies of the information requested in the Appendix.
