- (1) A public hearing shall be held on March 22, 2011 at 10:00 a.m. at the Commission's offices in Frankfort, Kentucky.
  - (2) Taylor County shall file an affidavit with the Commission no later than 21 days from the date of this Order attesting to its compliance or noncompliance with the requirements of 807 KAR 5:056.
  - (3) All documents filed with the Commission pursuant to 807 KAR 5:056, Section 1 (7) and (9) during the period under review are incorporated by reference into the record of this proceeding.
  - (4) Taylor County shall publish notice not less than 7 days or more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas. Taylor County shall also file an Affidavit of Publication of Hearing Notice with the Commission no later than March 18, 2011.
  - (5) The official record of the proceeding shall be by video only.
  - (6) Taylor County shall file with the Commission no later than 30 days from the date of this Order, the original and 10 copies of the information requested in the Appendix.
