- (1) Kentucky Power shall appear in Hearing Room 1 of the Commission's offices on October 18, 2011 at 10:00 a.m. to submit itself to examination of the application of its FAC from November 1, 2010 through April 30, 2011.
  - (2) Not less than 7 days nor more than 21 days prior to the scheduled hearing, Kentucky Power shall publish in a newspaper of general circulation in each area in which it serves notice of the scheduled hearing.
  - (3) Kentucky Power shall file with the Commission no later than October 14, 2011 proof of publication of its notice for the hearing.
  - (4) The official record of the proceeding shall be by video only.
  - (5) a. The information requested in the Appendix is due not later than 21 days from the date of this Order.
  - (5) b. Each response shall be answered under oath.
  - (5) c. A party shall make timely amendment to any prior response.
  - (5) d. Any request a party refuses to furnish the requested information, that party shall provide a written explanation.
  - (6) Any party who wishes to file testimony in this proceeding may petition the Commission for a procedural schedule.
  - (7) All documents that Kentucky Power filed with the Commission during the period under review pursuant to 807 KAR 5:056, Section 1 (7) and (9) are incorporated by reference into the record of this proceeding.
