 - (5) Each party shall notify the Commission in writing if this matter may be submitted for decision based on existing record without hearing.
 - (6) Unless all parties request that this matter be submitted for decision upon the existing record, an informal conference shall be held on March 16, 2012 at 1:30.
 - (7) Unless all parties request this matter be submitted for decision upon the existing record, a formal hearing shall be held in the Commission's offices at a date and time to be announced.
