 04/09/12    Final Order Entered: (1) NKWD is granted a Certificate to construct the proposed project as set forth in its application. (2) NKWD shall notify the Commission prior to performing any additional construction not expressly authorized by this Order. (3) Any deviation from the construction approved shall be undertaken only with the prior approval of the Commission. NKWD shall furnish documentation of the total costs of this project within 60 days of the date that construction is substantially completed. (4) NKWD shall file a copy of the "as-built" drawings and a certified statement that the construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of substantial completion of the construction certificated herein. (5) NKWD shall require construction be inspected under general supervision of licensed professional engineer to ensure the construction work is done in accordance with contract drawings and specifications and in conformance with the best practices of construction trades involved in the project. (6) NKWD's application for approval of its plan of financing for the proposed project is denied as moot. (7) Any documents filed in the future pursuant to this Order shall reference this case number and shall be retained in the utility's general correspondence file.
