(7) Rowan shall file a copy of the "as-built" drawings and a certified statement that construction has been satisfactorily completed in accordance with contract plans and specifications within 60 days of substantial completion of the constructions certified herein. (8) Rowan shall require construction be inspected under general supervision of professional engineer with Kentucky registration in civil or mechanical engineering. (9) Rowan shall notify Commission one week prior to actual start of construction and at 50 percent completion point. (10) Rates set for in Appendix are approved for service rendered on and after date of this Order. (11) Within 30 days, Rowan shall file revised tariff
