(7) The hearing scheduled for January 15,2013 is cancelled. (8) Upon payment of the \$1,875.00 civil penalty, this case shall be closed and removed from the Commission's docket without

(3) At the scheduled hearing in this matter, Mountain Rural shall also present evidence on the adequacy, safety, and reasonableness of its practices related to the construction, installation, and repair of facilities and whether such practices require revision as related to this incident. (4) The January 15, 2013 hearing shall be recorded by videotape only. (5) The Report in the Appendix to this Order is made a part of the record in this case. (6) Any requests for an informal conference with Commission Staff shall be set forth in writing and filed with the Commission within 20 days of the date of this Order.
