Final Order Entered: (1) NKWD is granted a Certificate of Public Convenience and Necessity to proceed with the proposed construction set forth in its application. (2) NKWD shall obtain approval from the Commission prior to performing any additional construction not expressly authorized by this Order. (3) Any deviation from the construction approved shall be undertaken only with the prior approval of the Commission. (4) NKWD shall furnish documentation of the total costs of this project including the cost of construction and all other capitalized costs, such as engineering,

legal, and administrative expenses, within 60 days of the date that construction is substantially completed. (6) NKWD shall file with the Commission a copy of the "as-built" drawings and a certified statement that the construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of the substantial completion of the construction certified herein.
