 d. For any request to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.  
 3. Any party that files written testimony shall file with the Commission an original and eight copies. Written testimony shall be in verified form.
