Jackson Energy shall provide a complete notice of its proposed rates to its customers in Breathitt, Garrard, Leslie, Lincoln, Madison, Powell, Pulaski, and Wolfe counties in accordance with 807 KAR 5:001, Section 16(3)(b), by either: (1) including notice with customer bills; (2) publishing notice in a trade publication or newsletter going to all customers in each of those counties; or (3) publishing notice once a week for three

consecutive weeks in a prominent manner in a newspaper of general circulation in each service area. The notice provided to its customers shall include the corrections to rates contained in its response to the deficiency letter so that the complete correct notice is provided to its customers in those counties.
