2. Pursuant to 807 KAR 5:001, Section 9(2), Richardsville Gas shall serve notice of the hearing's date and time to its customers no less than 14 days and no more than 21 days prior to the date of the hearing. Richardsville Gas shall provide a copy of the notice to the Commission on or before the date of the hearing.  
3. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9)(a), the record of the formal hearing in this matter shall be by videotape.
