Order Entered: Contracts and amendments to contracts for the sale for resale of water by a city-owned utility to a Commission-regulated water utility shall be filed by the seller with the Commission pursuant to KRS 278.200, but the Commission-regulated water utility need not obtain approval as an evidence of indebtedness under KRS 278.300 of any minimum purchase requirements or minimum service charges in such a contract or amendment.

2. In the future, when Hardin District No. 2 enters into a contract with a city owned water utility that requires Hardin District No. 2 to apply for a Certificate of Public Convenience and Necessity, Hardin District No. 2 shall file with the Commission the contract for approval along with the application for a Certificate of Public Convenience and Necessity.
