Responses to requests for information shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided. b. Each response shall be answered under oath or be accompanied by a signed certification of preparer or person supervising preparation of response on behalf of entity that response is true and accurate to best of that person's knowledge, information, and belief formed after a reasonable inquiry.
