  - a. Its written comments on and any objections to the findings and recommendations contained in the Staff Report;
  - b. Any additional evidence for the Commission's consideration; and, c. Written notice as to whether this matter may be submitted for
  - decision based upon the existing record.
  - 3. If Commission Staff finds that East Daviess' financial condition supports a higher rate than East Daviess proposes, or the assessment of an additional rate or charge not proposed in East Daviess' application, East Daviess in its response to the Staff Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the recommended additional rate or charge.
