1. Movant's motion for confidential protection is granted.

The coal bid analysis information for which Movant seeks confidential treatment shall not be placed in the public record or made available for public inspection until February 28, 2019, at which time the materials will be placed in the public record. Movant may request that the material continue to be treated as confidential, but must demonstrate that the material still falls within the exclusions established in KRS 61.878.
 3. The coal price settlement agreement information and the litigation settlement information for which Movant seeks confidential treatment shall not be placed in the public record or made available for public inspection indefinitely, unless the information becomes public, at which time the materials will be placed in the public record. Movant may request that the material continue to be treated as confidential, but must demonstrate that the material still falls within the exclusions established in KRS 61.878.

 2. Not less than seven days and nor more than 21 days prior to the scheduled hearing, KU shall publish, in a newspaper of general circulation in each area in which it serves, notice of the purpose, time, place and date of the scheduled hearing.
 3. KU shall file with the Commission no later than April 7, 2014, proof of publication of its notice for the hearing.
 4. The official record of the proceeding shall be by video only.
