Richardsville shall file the first summary of activity and transactions of its safety surcharge, for calendar year 2014, by March 31, 2015, and annually thereafter for each succeeding year until the surcharge is terminated.</li> <li>6. Richardsville shall file the first summary of activity and transactions of its propane surcharge, for calendar year 2014, by March 31, 2015, and annually thereafter for each succeeding year until the surcharge is terminated.</li> </ol>
